If accepted, I agree to be open during all hours of the event and offer only the items from above that are approved by Carteret. I will keep my area clean. All vendors must supply their own tables, lights, generators, outdoor extension cords. Novelty vendors agree not to sell or display silly string or bang snaps and anything like them, if you are found doing so you may be asked to leave and no refund will be given. If you are using frying oil, you must ensure it does not spill on the ground when cooking, and you must dispose of the frying oil after the close of the event. If there are remains on the ground, Carteret will be issuing fines. **If you are serving food it must be prepared in a licensed facility or prepared on location, under no circumstances should food be prepared at home. No food vendor will be allowed to participate without meeting the necessary requirements (Please see the attached information from the Board of Health for further details).** I understand that all decisions made by Carteret Event Committee are final. Failure to abide by the above mentioned rules could prohibit my participation in this event.
